The new WaterMark Administrator – The Australian Building Codes Board (ABCB) has notified IAPMO Oceana (and the other WaterMark Conformity Assessment Bodies (WMCAB)); that all new or endorsed WaterMark Certificates are to identify the WaterMark licence number with a prefix which includes the initial of the WMCAB, the text 'WM' followed by the reference number, a suffix detailing both the version of the certificate issue (i.e. for renewal) and the revision.
